Information clause on the processing of personal data

4. Time limit for keeping the data

The personal data will be kept for two weeks and subsequently deleted.

5. You have the following rights

- Right to access your personal data,
- Right rectify your personal data
- Right to limit the processing of the personal data or to delete them.
- Right to lodge a complaint with the President of the Office for Personal Data Protection (UODO) (ul. Stawki 2, 00-193 Warszawa)) if you believe the data have been processed in breach of the GDPR.

6. Providing personal data is voluntary, yet it is a requisite for attending the event. Person will not be admitted to the festival without filled in and signed health declaration.
